Collection of E-Waste, segregating, shredding are being carried on currently and construction of the plant will commence soon. (5) Cerebra ME FZCO(UAE) continued to bag larger orders and achieved significantly improved business. (6) Without qualifying their report the Auditors have observed in their report as: a. Long term Advance of Rs. 679.76 Lakhs. Capital Advance of Rs. 1529.09 Lakhs have not been recovered for substantial period.
